ALL BOATS MUST BE COVERED BY LIABILITY INSURANCE AND MEET COAST GUARD SAFETY REQUIREMENTS; ANY VIOLATION OF THE WATERWAYS WILL RESULT IN DISQUALIFICATION.

1. TOURNAMENT DIRECTOR RESERVES THE RIGHT TO DENY REGISTRATION TO ANY ANGLER.
2. LIFE VESTS AND KILL SWITCHES REQUIRED TO BE WORN WHENEVER THE BOAT IS ON PLANE.
3. LIVE WELLS MUST BE AERATED. NO ICE FISH ALLOWED. Two(2) OZ PENALTY FOR EACH DEAD FISH.
4. LIVE WELLS WILL BE CHECKED. NO LIVE BAIT, TROLLING, OR JIGGER POLLING PERMITTED.
5. ALL BOATS MUST CHECK-IN AT THE REGISTRATION TABLE PRIOR TO BLAST-OFF OR BE DISQUALIFIED.
6. ALL BOATS MUST BLAST OFF AND CHECK-IN BY BOAT NUMBER.
7. **FIVE (5) FISH LIMIT PER BOAT**, LARGE MOUTH AND SPOTTED BASS ONLY.
8. BOATERS SHOULD CULL TO THE 5 FISH LIMIT BEFORE CONTINUING TO FISH. NO CULLING OF FISH AT RAMP. IF MORE THAN 5 FISH ARE BROUGHT TO THE SCALES, FISH WILL BE CULLED BEGINNING WITH THE LARGEST FISH.
9. MINIMUM LENGTH OF FISH IS **12 INCHES** ON A GOLDEN RULE, MOUTH CLOSED AND TAIL SWEEP.
10. BOATER WEIGHING IN A **SHORT FISH** WILL LOSE THE SHORT FISH AND BE ASSESSED A ONE-POUND PENALTY FOR EACH SHORT FISH.
11. FLIGHT 1 CHECK-IN IS AT 2:00 P.M. SUBSEQUENT FLIGHTS CHECK-IN 15 MINUTES LATER THAN THE PREVIOUS FLIGHT. A ONE POUND PER MINUTE PENALTY WILL BE ASSESSED FOR BOATS CHECKING IN LATE. BOATS LATER THAN 10 MINUTES WILL BE DISQUALIFIED.
12. SIGNATURE ON ENTRY FORM IS CONSIDERED CONSENT FOR POLYGRAPH TEST. AT LEAST 1 TEAM MEMBER MUST BE MEDICALLY ABLE TO HAVE POLYGRAPH ADMINISTERED TO THEM. TOURNAMENT DIRECTOR RESERVES THE RIGHT TO REQUEST POLYGRAPH OF ANY CONTESTANT. REFUSAL TO TAKE POLYGRAPH OR FAILURE OF POLYGRAPH WILL RESULT IN DISQUALIFICATION.
13. NO ALCOHOLIC BEVERAGES OR DRUGS ALLOWED DURING THE TOURNAMENT OR WEIGH-IN. ALCOHOL PERMITTED ONLY AFTER ALL POLYGRAPHS HAVE BEEN ADMINISTERED.
14. BOATERS ARE EXPECTED TO DISPLAY GOOD SPORTSMANSHIP AT ALL TIMES.
15. FOR SAFETY'S SAKE, ANY BOATERS CHOOSING TO EXIT THE TOURNAMENT PRIOR TO WEIGH-IN ARE REQUESTED TO NOTIFY TOURNAMENT STAFF OR A FELLOW BOATER.

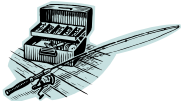

COVENANT NOT TO SUE AND WAIVER OF SUBROGATION

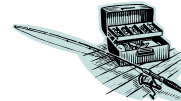
I further agree to never sue for damages resulting from any injury or damage suffered or caused by me whether known now or which may develop in the future.
